Persons. The actual Enumeration shall be made within three Years after the first  
of ten Years, in such Manner as they shall by Law direct. The Number of  
shall have at least one Representative, and the Enumeration shall be made  
its eight, Rhode Island and Massachusetts one, Connecticut five, New  
Virginia ten, North Carolina five, South Carolina five, and Georgia three.  
Representation from any State shall be proportionally thereto. The Number of  
shall choose their Officers and other Officers, and shall have the sole Power of  
States shall be equal to two Senators from each State, chosen by the Legislature  
be assembled in one Place, the first Time, shall be divided as equal Clauses,  
be vacated at the Expiration of the second Year, of the second Class at the Expiration  
so that one third may be chosen every second Year, and if Vacancies happen  
the Executive Power, until their next Meeting.
